Request for Statement of Interest
Family Child Care Environment Rating Scale Trainer

The Office of Child Care is seeking an experienced, dynamic individual to conduct trainings for family child care home providers on the Family Child Care Environment Rating Scale (FCCERS) for the Steps to Excellence Project (STEP). This position will provide training services on an as-needed basis. The Office of Child Care is situated in the Service Integration Branch of the Los Angeles County Chief Executive Office and is located at 222 South Hill Street in Los Angeles, California.

Project

Description: STEP is a new child care quality rating and improvement system that is being piloted in the following communities of Los Angeles County:

Licensed child development centers serving children ages 0-5 and licensed family child care homes are eligible to participate in STEP. The STEP quality assessment process for family child care homes includes the use of the FCCERS to assess the quality of the learning environment.

Project

Period: STEP is a 3-year pilot project operating from July 2007 to June 2010. It is estimated that the FCCERS Trainer will provide a maximum of 3 to 4 trainings per quarter beginning January 2009 and on an as-needed basis thereafter.

Duties:

Working closely with STEP's Project Manager and Training Coordinator, the contracted trainer will develop and conduct training sessions on the FCCERS observation tool for family child care providers. Trainings will increase participant's understanding of the FCCERS, provide guidance on how to use the FCCERS to make quality improvements, and will provide practical tips to help participants prepare for FCCERS quality observation visits.

Minimum

Qualifications: Bachelor of Arts degree in Child Development or closely allied field; expert knowledge and understanding of the FCCERS; completion of FCCERS reliability training; experience working in child care and development programs; verified and successful experience as a group trainer; excellent communication skills; demonstrated knowledge of adult learner instructional strategies; attention to detail and deadlines; and a dependable car to travel to selected community-based venues to implement trainings. Availability during evening hours and/or Saturdays is required.

Preferred

Qualifications: Masters degree in Child Development or closely related field; and the ability to conduct FCCERS trainings in Spanish is strongly desired.

Evaluation

and Selection: Applicants will be selected based upon FCCERS expertise, training experience, and performance during a training demonstration to be conducted as part of the interview process.
